Terms of Sale & Warranty Information

1. All sales are final.
2. If within 90 days of purchase a mechanical part proves defective, seller will—within a reasonable period of time—replace the part.
3. Seller is not responsible or liable for any incidental or consequential damages.
4. No warranty or reimbursement on labor under any circumstance.
5. No cash refunds.
6. In the event a mechanical part is defective and a replacement is not obtainable, a refund will be made by company check.
7. Keep your receipt; no claims or warranties can be made without it.
8. Unless stated otherwise on the face of the receipt, no other warranty is made or implied.
9. Damages or altered parts or not warranted: parts must be returned in the same condition as at sale.
10. Seller is not responsible for buyer's error.
11. No core deposits refunded after 30 days.
12. KARS makes no claim as to the suitability of any part for a particular purpose. Buyer is responsible for determining suitability of parts purchased for purpose intended.
13. If at seller's sole discretion a non-warranty return is allowed, a 25% restocking fee will be charged.
14. If you have a problem, contact KARS prior to removing part or attempting any repair to part.
15. Returned checks subject to \$35.00 fee.
16. All sheet metal, glass, and body parts are sold as-is.
17. No claims on body parts, color, or trim packages.

Special Order Policies

1. Special orders are non-returnable.
2. A minimum deposit of 50% is required for all special orders.
3. Deposits are non-refundable.
4. Parts and deposits left unclaimed over 30 days shall be forfeited.
5. Seller is not responsible for delays in UPS or freight shipments; freight delivery is beyond the seller's control.
6. All conditions listed under Terms of Sale (above) apply to special orders.

Engine Warranty

1. Used engines are guaranteed not to have cracked block, head, or bad crankshaft. Parts external to the cylinder block and the cylinder head(s) (i.e. coil pack, distributor, sensors, etc.) are not warranted. These are left on the engine for the installer's convenience only.
2. No warranty on seals, gaskets, fluids or coolant.
3. Overheating voids all warranties.
4. Used engines guaranteed against rod knock, excessive smoking, and excessive oil consumption.
5. It is recommended that the buyer replace the rear main seal and inspect gasket prior to installation.
6. All conditions listed under terms of sale (above) apply to engine purchases.

Transmission Warranty

1. Improper detent adjustment, low fluid level, failure to install new filter (A.T. only), broken front pump, or improper installation voids all warranties.
2. It is recommended buyer replace front seal prior to installation.
3. Proper fluid type must be used; transmission lines and cooler must be flushed prior to installation.
4. All conditions listed under terms of sale (above) apply to transmission purchases.
